**AN ORDINANCE TO AMEND ARTICLE IV, SECTION 10-71  
“MONTHLY SEWER SERVICE CHARGES” OF THE 2015 SEWER  
USE ORDINANCE.**

**BE IT ORDAINED** by the Mayor and City Council of the City of Inman:

**Section 1. Monthly Sewer Service Charges Amended.**

Article IV, Section 10-71 “Monthly Sewer Service Charges” of the 2015 Sewer Use Ordinance is amended to read as follows:

- A. All users are required to pay a sewer service charge composed of a monthly base charge, as well as a volumetric rate per 1,000 gallons of billable wastewater flow. The following rates are in effect for all users of the sanitary sewer system until amended by the City Council:

B. For the purpose of determining wastewater volume, the user's metered water consumption will be used. An adjustment may be made (at the City's discretion and with the City's approval, on a limited basis only) to deduct water usage for purposes not requiring discharge into the sanitary sewer. For users that obtain water from an unmetered well, a discharge flow meter approved by the City will be installed at a location accessible to the City. If a substantial amount of water is used for purposes that do not require discharge into the sanitary sewer system, the user will be allowed an option of installing, at the user's expense, a recording meter, of a design approved by the City, for determining wastewater volume.

**Section 2. Severability.**

The invalidity of any provision of this Ordinance will not affect the validity of the remaining provisions.

**Section 3. Effective Date.**

This Ordinance will take effect on September 1, 2018 upon second reading approval.
